Pursuant to the authority vested by the Department of Transportation (DOTr) to the Land Transportation Office to issue guidelines relative to the authorization of Private Motor Vehicle Inspection Centers (PMVICs) and under LTO Memorandum Circular No. 2018-2158 dated 28 November 2018, re: GUIDELINES FOR THE AUTHORIZATION OF PRIVATE MOTOR VEHICLE INSPECTION CENTERS (PMVICs), it is hereby directed that all PMVICs granted with Authorization shall commence operations effective immediately.

In view thereof, below is the initial list of PMVICs authorized to conduct road worthiness inspections and emission compliance tests of motor vehicles and their respective provisional Geographical Areas of Responsibility (GAOR).

**PROVISIONAL AUTHORIZATION
 CERTIFICATE TO OPERATE A
 PRIVATE MOTOR VEHICLE INSPECTION CENTER**

Pursuant to Memorandum Circular (MC) 2019-009 dated 13 March 2019 (Revised Guidelines for Authorization of Private Motor Vehicle Inspection Center) and Private Motor Vehicle Inspection Center (PMVIC) Authorization Committee Resolution No. PMVIC-PAC-2021-03, the Committee hereby grants Provisional Authorization Certificate to **BIO MOTORS, INC.** to operate a PMVIC in **Region 5 - Daet, Camarines Norte.**


This Provisional Authority is issued in view of the pendency with the Department of Agrarian Reform (DAR), Regional Office V, of a Petition for Revocation of the Order of Conversion from agricultural to industrial of the lot where the PMVIC facility of **BIO MOTORS, INC.** is constructed and is subject to compliance of said proponent with the requirements for facilities and equipment, particularly regarding its Headlight Tester for Motorcycles, in accordance with Section 17(b) (Inspection Equipment and Specification for Motorcycle) of MC No. 2019-009.


The Provisional Authority shall only be for a period of thirty (30) calendar days reckoned from receipt of this Provisional Authorization Certificate and shall remain until finality of the Order of Conversion be issued in favor of **BIO MOTORS, INC.**

In view of its Provisional Authority, **BIO MOTORS, INC.** may collect not more than the amount of inspection fee indicated in the Schedule of Fees provided by the Land Transportation Office.

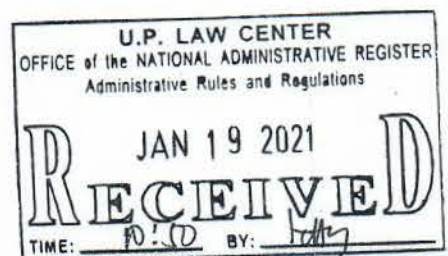
