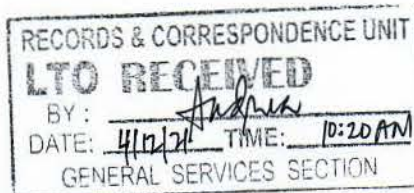

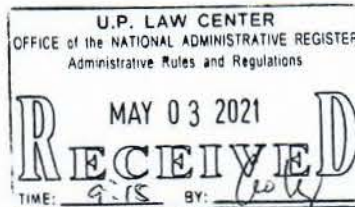


MEMORANDUM CIRCULAR NO. 2021-2259

SUBJECT : EXTENDED VALIDITY OF REGISTRATION AND LICENSES/
PERMITS IN NCR PLUS AND OTHER IDENTIFIED AREAS



In view of the declaration placing the provinces of Bulacan, Cavite, Laguna, the City of Santiago in Isabela, Quirino Province, Abra in the Cordillera Administrative Region and Rizal together with the highly urbanized cities of the National Capital Region, and the municipality of Pateros under Modified Enhanced Community Quarantine (MECQ) from April 12-30, 2021 due to the COVID-19 pandemic, and to strictly implement the observance of social distancing and other health and sanitary protocols to protect the health and safety of our employees, as well as our clients, it is hereby directed that:

1. The previous extension for validity of registration of motor vehicles with plate number ending in "3" and "4" under **MEMORANDUM CIRCULAR NO. 2021-2257** dated 28 March 2021 is **hereby amended** to read as follows:

PLATE NUMBER ENDING	EXTENDED VALIDITY
3	30 June 2021
4	31 July 2021

Upon resumption of work in these areas, to ensure compliance to health protocols and social distancing guidelines, the weekly schedule for the middle digit of these plate numbers shall still be observed and encouraged, without collection, however, of surcharge and/or penalty during the duration of the extended validity, as illustrated below:

MIDDLE DIGIT OF PLATE ENDING IN 3 OR 4	WHEN TO TRANSACT WITH LTO
1, 2, 3	MAY 1-7; JUNE 1-7; JULY 1-7
4, 5, 6	MAY 8-14; JUNE 8-14; JULY 8-14
7, 8	MAY 15-21; JUNE 15-21; JULY 15-21


9, 0	MAY 22-31; JUNE 22-30; JULY 22-31

2. The previous extension for validity of driver's and conductor's licenses and student permits under MEMORANDUM dated 29 March 2021 is hereby amended to read as follows:

The validity of **ALL** student-driver's permits (SDP), driver's licenses (DL) and conductor's licenses (CL) that **expired during the ECQ and MECQ declaration from March 29, 2021 to April 30, 2021**, shall be **extended until 31 July 2021**. Accordingly, the validity of medical certificates that expired during the said period of ECQ/MECQ declaration is accordingly extended until transaction date or 31 July 2021, whichever comes earlier.

All memoranda, orders, circulars, and other issuances in conflict herewith are hereby revised or superseded accordingly.
