SUBJECT : FULL IMPLEMENTATION OF LAND TRANSPORTATION MANAGEMENT SYSTEM (LTMS) IN THE REMAINING LICENSING CENTERS - DRIVER'S LICENSING SYSTEM (DLS), REVENUE COLLECTION SYSTEM (RCS) AND LAW ENFORCEMENT & TRAFFIC ADJUDICATION SYSTEM (LETAS)



In congruence with the complete rollout of the Land Transportation Management System (LTMS); all LTO sites with installed Driver's Licensing System (DLS) , Revenue Collection System (RCS) as well as Law Enforcement and Traffic Adjudication System (LETAS) are hereby directed to fully utilize the said systems in all driver's license transactions including Student Permit transactions and settlement of apprehensions.

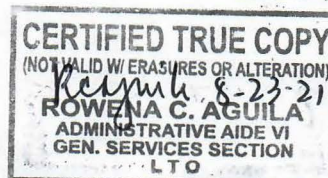
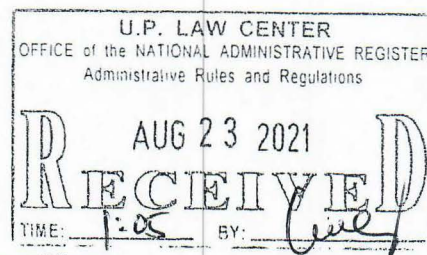
Anent thereto, **all remaining Licensing Centers shall fully use the new LTMS System effective 07 September 2021** and shall be monitored by the management. Attached herewith is the list of the remaining thirteen (13) Licensing Centers covered by this Memorandum Circular for reference.

Accordingly, no new or renewal DL transactions shall be processed using the old LTO-IT system in all LTO sites with the aforementioned systems. All sites with pending issues are directed to immediately notify the Management Information Division (MID) thru email address: mid-centraloffice@lto.gov.ph.

Failure to comply on the implementation hereof shall be dealt with accordingly.
