SUBJECT : SPECIFICATION AND REGISTRATION OF BYD SONG PRO EV

Pursuant to the provisions of Section 8, Article II of Republic Act No. 4136 on the Uniformity of Registration Fees and Classification, and Section 5 of Republic Act No. 8794 on the Reclassification and New Models of Motor Vehicle, all manufacturers and/or assemblers of motor vehicles, prior to the introduction of a new model motor vehicle, shall submit the specifications of said model to the Land Transportation Office which shall determine under what schedule of registration fees the said model should fall.
