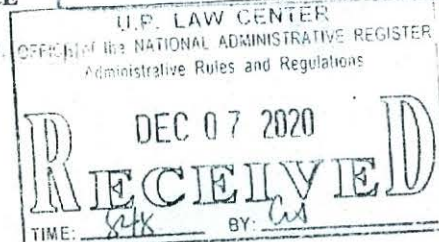
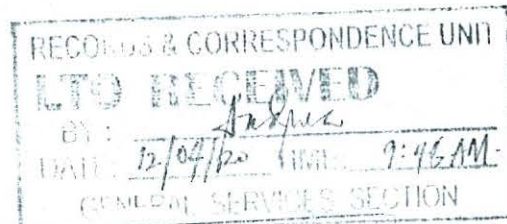

MEMORANDUM CIRCULAR No. 2020- 2230

SUBJECT : DECLARATION OF OPENING OF IDENTIFIED ADDITIONAL SITES CATERING HEAVY DUTY MOTOR VEHICLES FOR THE ESTABLISHMENT OF PRIVATE MOTOR VEHICLE INSPECTION CENTERS (PMVICs)

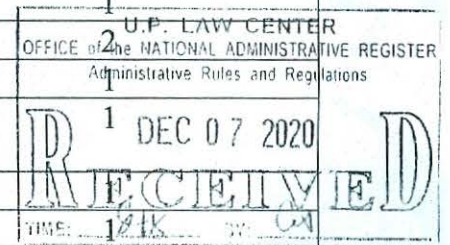
WHEREAS, the Department of Transportation- Land Transportation Office (DOT-LTO) issued Memorandum Circular (MC) 2019-009, "Revised Guidelines for the Authorization of Private Motor Vehicle Inspection Center (PMVIC)" dated 13 March 2019.

WHEREAS, Section 2(G) of MC No. 2019-009 provides that the PMVIC Authorization Committee (AC) shall have the authority to evaluate specific areas where additional PMVICs should be established taking into account the number of registered vehicles in coordination with LTO.

WHEREAS, through Resolution No. PMVIC-2020-VAR-02, the PMVIC AC resolved to adopt and approve the opening of additional sites submitted by LTO for the establishment of PMVICs, to wit:
