STUDENT-DRIVER'S PERMITS AFFECTED BY THE
IMPLEMENTATION OF MEMORANDUM CIRCULAR NO. 2018-
2157 (ONLINE MEDICAL CERTIFICATE)

All Driver's Licenses due for renewal on 07 to 11 January 2019 shall be accepted without the corresponding penalty until 20 January 2019.

For Student-Driver's Permits that expired on 07 to 11 January 2019, the validity is hereby extended to 20 January 2019.

This Memorandum Circular shall take effect immediately.

In our effort to serve the public better and to conform with the mandate of the law, Republic Act No. 11032, Ease of Doing Business and Efficient Delivery of Government Services Act of 2018 to Automate Transactions, we included the online medical certificate submission.

Memorandum Circular No. 20 18-2157 on the Revised Guidelines for Medical Examination, Accreditation of Medical Clinics and Registration of Physicians Relative to the Issuance of Medical Certificates to Student-Driver's Permits and Driver's/Conductor's License Applicants was implemented in LTO NCR on January 7, 2019.

As a new project, there were system glitches reported and although we trained the doctors on the use of biometric examination and uploading of results in LTO System, still there were delays experienced, as expected of any new system.

Hence, in order not to disrupt the delivery of our licensing services, **PENALTIES FOR LICENSES WHICH EXPIRE DUE TO THIS SYSTEM GLITCH WILL NOT BE COLLECTED.**
