SUBJECT : CLARIFICATION ON THE COLLECTION OF MOTOR VEHICLE USER'S CHARGE (MVUC) IN THE MOTOR VEHICLE REGISTRATION

INSPECTION SYSTEM (MVIRS)

Pursuant to Republic Act No. 4136, otherwise known as the "Land Transportation and Traffic Code", Republic Act No. 8794, otherwise known as the "Motor Vehicle User's Charge" (MVUC) law and other related issuances, and in line with the foregoing transition of the MVIRS, a uniform interpretation and implementation in the collection of MVUC is hereby clarified.

I. MVUC Collection on Initial Registration

The corresponding computation of MVUC portion of the year shall be collected based on the table below, in accordance with Section 5 of Circular No. 82-028 dated June 08, 1982, as illustrated table below:

The MVUC collection on initial registration shall be 1 year to 1 ¾ year and 3 years to 3 ¾ years, whichever is applicable.

The Official Receipt shall indicate: "This payment is valid until __ and due for renewal on __", in addition to automated emails of advisory sent to the registered email address of the client

II. MVUC Collection on Renewal

A. License Plate issued after initial registration in the Old System and before initial renewal in the MVIRS



Illustration 1: 1-Year and 3-Year Registration (whichever applicable)

If the renewal application of the motor vehicle follows the temporary plate and or permanent plate schedule or within the renewal schedule, the MVUC portion amount shall be collected. And if any case, renewal application was made beyond the scheduled renewal registration, MVUC portion amount and penalty shall be collected, the same is illustrated by the following example:

Illustration 2: Advance Renewal for 1-Year and 3-Year Registration (whichever applicable)

When renewal registration is made **two (2) months** before the scheduled renewal application, it is deemed to be an *advance renewal* **and applicable portion of the MVUC shall be collected.** as illustrated in the table below:

If in case, a penalty was <u>inadvertently collected</u> due to change of renewal schedule arising from the issuance of permanent plate, and renewal registration is not considered late, as illustrated in the table below:

An adjustment on the MVUC and/or fines and penalties shall be made to be applied for the next renewal. The Head of Office or Assistant Chief shall be given an authority to access and make the necessary adjustment during its succeeding renewal.

B. License Plate issued after initial registration in the Old System and after first renewal in the MVIRS

The MVUC portion amount shall be collected in the succeeding renewal schedule after the plate was issued.

Moreover, all heads of NRUs and authorized District/Extension Offices shall ensure that applicable MVUC portion of the year shall be collected based on the plate ending issued upon release of the permanent plate.

All circulars and orders inconsistent herewith are deemed superseded.
